Annual PC meeting

We held our yearly meeting in Bialowieza/Poland, on the border with Belarus, on 26-30 August 2014. It was attended by half the PC. We could welcome a new PC member: Francisco Moreira (Portugal). The focus of our discussions was the upcoming ICCB-ECCB (see below). We also dedicated one day to excursions to the core zone of the national park (the largest relict of temperate primary forest in lowland Europe) and different management regimes in the buffer zone. Roadless Areas Initiative



One PC member (Nuria Selva) was member of the Program Committee of the 2014 Infra Eco Network Europe (IENE) International Conference "Life for a Greener Transport Infrastructure" (http://iene2014.iene.info/). PC-Europe organised one symposium, contributed a plenary talk and two more talks. Another important feat with a lot of input by the initiative was the "IENE 2014 Roadless Areas Declaration" of the conference —

A book chapter on roadless areas and their conservation was recently accepted (publication due approx. July 2015)¹.

Natura 2000

The EU Habitats and Birds Directives, as well as the Natura 2000 complex of protected areas, represent another important focus of the work of our Policy Committee. EU conservation policy is currently confronted with a potential revision (including a "Fitness Check" of the directives) enforced by the EU Commission (also see below: Outlook). - A paper resulting from a survey at the ECCB 2009 in Prague was published². For its diffusion, the paper was distributed to the respondents of the survey. - A talk on management of Special Protection Areas under climate change was held at the annual conference of the German Ornithologists' Society in September in Bielefeld. A short article was produced from it and published in a German ornithological journal³.

EU agricultural reform fails on biodiversity

Extra steps by Member States are needed to protect farmed and grassland ecosystems

Declines in species richness seem to have slowed for a few taxa in parts of northwestern Europe (3), albeit at a biodiversityimpoverished status cuo. systems with higher environmental impact than all other policies and directives [sup-plementary materials (SM) part AJ Recognizing the role of the CAP for biodiver sity the BU Biodiversity Strategy for 2000 set Target AJ to "maximise areas [...] covered by biodiversity-violated measures under the CAP" (9). The CAP reform does not fulfill this storm.

THE DILITION OF AMBITION. When the European Commission lunched the latest CAP reform in 2010, it outlined three main challenges: food security, environment and climate change, and maintaining the territorial balance and diversity of rural area (9). To help address the second challenge, 30% of direct payments to farmers ("Fillat T) were to become conditional on compilIn 2013 and 2014, the Policy Committee got involved in NGO consultations in the context of the final negotiations for the reform of the Common Agricultural Policy of the EU. We assumed the lead in expert surveys, among others, on existing data on high nature value grasslands. These efforts resulted in a Policy Forum paper in the Science magazine⁴.

Extensive follow-up activities addressed diffusion and outreach both to decision-makers and fellow scientists. In two opportunities, main messages and potential policy implications were discussed directly with Members of the Parliament in Brussels (Breakfast meeting, visit to the Parliament). An SCB-ES letter is drafted to complement a letter by the authors of the Science article to the new Commissioner for Agriculture and Rural Development, Phil Hogan. The letter will also contain an invitation to attend a corresponding symposium at the ICCB-ECCB 2015 (see below).

Old-growth forests in Šumava National Park

The conservation of the remaining primary and old-growth forests in Europe has been an important topic for PC work for many years (among others, in Bialowieza – see above: Annual PC meeting). Representing another move in a long-standing activity addressing Šumava National Park, a letter prepared by the PC was approved by the BoD of SCB-ES, signed by the President of SCB-ES and sent

to the President of the Chamber of Deputies of the Parliament of the Czech Republic. The efforts of the SCB-ES strongly contributed to rejection of the Bill that was likely to enable activities likely to cause serious damage to the nature of Šumava National Park.

Diclofenac and vultures

Diclofenac, an anti-inflammatory drug used for humans and domestic animals, is notorious for being extremely harmful to raptor bird species, among other wildlife. After the EU Commission's decision to allow its use for domestic animals in the EU, PC-Europe started addressing this issue on the SCB website. We then prepared a letter, which, after its approval by the BoD of SCB-ES, was sent to the EU Commission. We received a response letter by the Commission that assures to review the problematic permission for diclofenac for treatment of domestic animals.
