# 2008 Work Plan

February 6, 2008

The Society for Conservation Biology's Social Science Working Group (SCB SSWG) is a global community of conservation professionals interested in the application of social science to the conservation of biological diversity. With nearly 700 members in more than 70 countries, the SSWG is home to a diverse array of social scientists (anthropologists, economists, human geographers, political scientists, psychologists, and sociologists), natural scientists, and conservation practitioners (governmental, nongovernmental, and private sector).

This document outlines the strategic direction of the SSWG and details the SSWG's planned activities for 2008.

#### Mission

The mission of the SSWG is to strengthen conservation social science and its application to conservation practice.

#### Vision

By 2010, we envision:

- conservation social science fully integrated within the structure, activities, and membership of SCB;
- increased social science awareness and capacity among conservation scientists and practitioners;
- widespread recognition of the SSWG as the leading organization for integration of social science into the science and practice of biodiversity conservation.

#### Goals

The SSWG has three principal goals:

- 1. Advance the development and dissemination of social scientific knowledge relevant to the conservation of biological diversity.
- 2. Foster the use of social scientific knowledge to resolve conservation problems.
- 3. Develop and carry out organizational core functions efficiently and effectively.

# 2008 Committee Work Plans

The SSWG Board and its Committees coordinate SSWG efforts to achieve these three goals.

# Goal 1. Advance the development and dissemination of social scientific knowledge relevant to the conservation of biological diversity.

# **Program Committee**

*Mission:* To promote SSWG's goal of strengthening conservation social science and its application to conservation practice, the SSWG Program Committee creates and implements strategies for integrating social and natural science information and expertise within SCB, between SCB and other professional societies, and in the published conservation literature.

# 1. Add two Committee members. (*Rich*)

*Rationale:* A full Program Committee is necessary to carry out the full range of planned activities.

- B. Recruit specific individuals who belong to both SCB and other social science professional organizations, whose crossover work will have prepared them well for program committee responsibilities.
- C. Recruit individuals whose backgrounds and interests will provide greater diversity to the leadership of both the Program Committee and SSWG.

# 2. Ensure effective SSWG presence at 2008 SCB Annual Meeting (*Rich Wallace*)

- A. Finalize social science program (organized sessions, contributed papers, SSWG social) (January February 2008)

# 3. Ensure effective presence at 2009 SCB annual meeting (Rich Wallace)

- A. Consult with 2009 SCB conference chair on the form and function of collaboration between SSWG and the steering committee (Feb-August 2008).
- B. Solicit session proposals (symposiums, workshops, organized discussions, short courses) for 2009 SCB annual meeting (Aug.-Oct. 2008).
- C. Review session proposals for 2009 SCB annual meeting (Oct.-Nov. 2008).
- D. Solicit and review abstracts for 2009 SCB annual meeting (Nov.2008-Feb.2009).
- E. Coordinate and promote SSWG activities at the meeting, including social science components of program agenda, business meeting, and social events (Sept 2008-June 2009).

- 4. Formally integrate SSWG into SCB conference planning (Rich Wallace, Mike Mascia)
  - A. Revisit protocols established by SCB Conference Committee and Board of Governors (May)
  - B. Work with SCB Conference Committee and BoG to refine conference planning procedures in time for SCB 2009 and 2009 section meetings (June-August, 2008)
- 5. Plan for SCB sectional meetings (Murray Rudd)
  - A. Reach out to Chairs of 2009 Sectional meetings (summer 2008)
  - B. Consult with Chairs re: meeting themes and topics (fall 2008)
  - C. Initiate specific activities for specific sectional meetings (as practicable; fall 2008-winter 2009).

- 8. Enhance role of social science in *Conservation Biology* (Kate Semmens, Ashley Schafer)
  - A. Identify all social science manuscripts previously published in *Conservation Biology* and define a way to measure them (to provide a qualitative appraisal of the content). (summer-fall 2008)
  - B. Compile the top ~10 social science papers from *Conservation Biology* so we can build a promotion of groundbreaking social science in the journal. (summer-fall 2008)
  - C. Work with the *CB* publisher Blackwell Synergy, Inc. and *CB* editor Gary Meffe to prepare a proposal for including *Conservation Biology* in the Social Science Citation Index. (to commence once A and B are completed).

# Resources:

One or two additional dedicated committee members will be needed to adequately staff the Program Committee's work plan beyond its current state. Toward this end, we are actively recruiting at SCB meetings, among the population of individuals who belong both to SCB and other social science professional organizations, and among individuals whose backgrounds and interests will provide greater diversity to the leadership of both the Program Committee and SSWG.

# **Education Committee**

*Mission*: To advance conservation social science knowledge, the SSWG Education Committee creates support for academics through forums and mechanisms for information exchange and learning with SCB, with other professional societies, and with in SCB journals.

#### Activities:

- 1. <u>Working Paper Series</u> (David Hoffman, Interim Managing Editor; Associate Editor TBD) *Rationale*: Working papers provide a unique opportunity for rapid dissemination of research insights and feedback from peers. Thus, the WPS is designed to provide researchers a venue to post new research articles for practitioner use and peer insights prior to regular journal submission.
  - A. Recruit new Managing Editor (Jan-April)
  - B. Refine and improve upon call for papers (CFP) to increase submission rate and quality (Spring 2008)
  - C. Redistribute CFP and improve targeted advertising of WPS to academic circles within and outside of the SCB (Spring 2008)
  - D. Continue to recruit, review and post working papers (ongoing)
- 2. Short Courses (Jane Packard, Dyana LaRosa, Altaf Hussain)

*Rationale*: Short courses are designed to build conservation social science capacity among academic and practitioner members of the SCB.

- A. Review SCB social science short courses (2005-2008) & assess niches for new courses (Jane Packard; Dyana LaRosa,).
- B. Develop Cultural Models short course for SCB 2009 (Jane Packard)
- C. Solicit and review short course proposals for SCB 2009 (Jane Packard)
- D. Investigate collaboration with AMNH Network of Conservation and Education Practitioners (Jane Packard)
- 3. Syllabi updates (Rinku Roy Chowdhury)

*Rationale*: Provide access to Conservation Social Science courses via the SSWG website to facilitate conservation and social science education around the globe.

- A. Review current syllabi holdings for existing gaps (Feb-March)
- B. Solicit new syllabi to fill existing gaps (April-June)
- C. Post new syllabi (June)

*Resources Needed*: At this point, the Education Committee has no financial resources. Consistent with last year's Work Plan, \$5,000 would enable the full membership of the Education Committee to attend the 2008 SCB meetings. A face to face meeting of this type would facilitate and improve the committee's work.

# Goal 2. Foster the use of social scientific knowledge to help solve conservation problems.

#### **Conservation Committee**

*Mission:* To help solve conservation problems, the SSWG Conservation Committee develops resource materials and conducts activities to build social science capacity among conservation practitioners. Current efforts focus on outreach in the form of (a) the compilation and dissemination of conservation social science tools and (b) provision of training for conservation professionals.

  - B. Diversify membership by establishing contact with professionals whose disciplines, conservation-related interests, and/or world regions of focus may be underrepresented on the committee (January-May)
  - C. Identify specific roles and associated duties for each Conservation Committee member (January-March, August-September)
- 2. <u>Maintain, improve, and promote the Online Catalog of Conservation Social Science Tools</u> (*Rodolfo Tello, Diane Russell*)
  - A. Update existing Catalog content and web links (January-May)
  - B. Assure that all gaps in introductory text are filled (e.g., descriptions of the principal social science disciplines) (June-October)
  - C. Identify additional resources that may be useful to include in the Catalog (ongoing)
  - D. Network with other professional groups that are creating or hosting similar resources (e.g., working with these groups to include a link to the Catalog on their website, and similarly providing a link to their materials in the Catalog) (July-September)
  - E. Recruit additional participants in Catalog maintenance and improvement, and contact individuals who already agreed to participate (reminding them of their commitment and confirming their ability to remain involved) (March-May)
  - F. Work with the Communications Committee to ensure consistency in overall website design/formatting and to improve SSWG website functioning (March-May)
- 3. Provide training to conservation professionals (*Tara Teel*)
  - A. Conduct a 4-day short course on the role of the social sciences in conservation planning in conjunction with the SCB 2008 Conference in Chattanooga, Tennessee (July)

- B. Explore ways to recruit and support short course participants from regions of the world under-represented within the SSWG and the broader conservation social science community (January-May)
- C. Follow-up with short course participants for purposes of course evaluation and provision of additional information on the SSWG (August)
- D. Work with the Education Committee (contact: David Hoffman) to identify areas of possible collaboration in short course development and participant recruitment (January-May)
- E. Seek other venues for future short courses (August-October)
- F. Evaluate short courses requesting SSWG sponsorship and provide feedback for improvement (September-December)
- 4. Explore additional outreach mechanisms for building social science capacity among conservation professionals (*Nora Haenn, Shannon Earle*)
  - A. Identify other existing outlets and new ways of disseminating practical information and tools (March-May)
  - B. Explore ways to share "success stories" in social science application with conservation practitioners (e.g., brief case study write-ups, building upon the Education Committee's idea of a Working Paper Series) (May-August)
  - C. Define needs and target audiences for future outreach activities (May-September)

#### Resources:

Funds are needed to support continued development and maintenance of the Online Catalog of Conservation Social Science Tools. In particular, approximately \$1,350 is needed in 2008 to provide partial support for a graduate student to work on website updates. This figure represents a stipend of \$150 per month for 9 months (10 hours per month @ \$15/hour). Resources will also be sought from various sources in 2008 to support short course development, implementation, and participant recruitment.

# **Policy Committee**

*Mission:* To help solve conservation problems, the SSWG Policy Committee develops resource materials -- scientific briefs, position statements, and other informational materials -- to aid conservation decision-makers inside and outside of government. Consistent with the SCB Policy on Policy, activities focus on two general policy arenas:

- **1.** Policy interventions introducing scientific knowledge and methodology into conservation policy.
- **2.** Policy interventions advocating specific conservation actions by governments or other major institutions.

- F. Finalize SSWG protocol (March 2009).

# 2. Coordinate SSWG involvement with the SCB Policy Committee.

Rationale: SSWG social science expertise can contribute to SCB Policy Committee activities.

- A. Initiate dialogue with SCB Policy Committee (July).
- B. Develop roster of SSWG policy expertise (coordinate w/Membership Committee) (August-Sept).
- C. Participate in relevant SCB Policy Committee activities (July-December).

# 3. Develop and disseminate resource materials consistent with SSWG policy protocol.

*Rationale:* Decision-makers will make more scientifically-sound conservation decisions when given additional social scientific knowledge.

- A. Review external policy proposals submitted to the SSWG for consideration (ongoing).
- B. Identify issues that merit development of SSWG resource materials (Nov-Dec 2008).
- C. Develop draft resource materials (Jan-April 2009; refinement and delivery in May-June 2009).

# **Communication Committee**

*Rationale*: A viable website is critical to facilitate communication with SSWG members and nonmembers.
